 - Presidents Report (Ian Hair) -

The WDVGA has 105 current members, down from 160 in 2020/21 and held 20 events were planned (9 greens, 11 scrapes), with one cancelled and we participated in two additional regional challenges. Average attendance was 33 players per event, which financially is just a break-even number. Attendance in 2016 was 61 and in 2021 was 43.
